No work shall be concealed until it has been inspected. When ready for inspection, log on to <https://bsaonline.com/?uid=292> by 3:30 P.M. (M-F) the day before to schedule an inspection. **YOU MUST HAVE THE PERMIT NUMBER AND ADDRESS AVAILABLE WHEN SETTING UP THE INSPECTION.**

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing & inspections are requested / conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit; or if the authorized work is suspended; or for a period of six months after the time of commencing the work; or date of last inspection.
